In the connection with currently valid regulations of the Government of the Slovak Republic and the measures of the Public Health Office of Slovak Republic (ÚVZ SR) against the spread of the COVID-19 pandemic for the Quarantine Center for Top Athletes, we confirm that:

as a top athlete or a member of the organizational team in the Quarantine Center for Top Athletes, in Šamorín.

Due to the strict measures taken by the Government of the Slovak Republic in resolving the complicated situation of the coronavirus pandemic COVID-19, a Quarantine Center for Top Athletes has been established in Šamorín¹ from 19th of November 2020 in order to help Slovak sport and ensure the continuity of sports training. **The statute of the Quarantine Center for Top Athletes** was supported by the State Secretary of the Ministry of Education, Youth and Sports of the Slovak Republic, Ivan Husár, as well as the Government Plenipotentiary for Youth and Sport, Karol Kučera, and **approved by the Central Crisis Management Staff**, respecting the stricter regime in connection with the fight against the spread of the coronavirus COVID-19.

A safe and controlled zone for accommodation, catering and sports training has been created in the area, respecting strict safety and hygiene measures. The measures also includes a quarantine accommodation pavilion, and controlled and limited access to sports grounds. All those who move in the hermetically sealed area of the Olympic Training Center must undergo an RT-PCR test for COVID-19.

The regime of operation of the quarantine center for elite sports is based on valid decisions, regime measures and guidelines so that it is in line with the main mission of Public Health Office, which is the protection and promotion of public health.

When entering the territory of the Slovak Republic, the obligatory quarantine does not apply² to the above-mentioned person on the basis of an exception for athletes and members of organizational teams who enter the territory of the Slovak Republic for top sports training in the Quarantine Training Center for Top Athletes, on Dubová ulica 33 / A, 931 01 Šamorín, under the authority of the Ministry of Education, Science, Research and Sports of the Slovak Republic.
